

RETURN OF GOODS FORM

In the case of distance contracts, the consumer is entitled to withdraw from the contract within 30 days from receipt of goods without having to state a reason for his or her decision. The only cost that the consumer will bear in relation to the withdrawal from the contract is the direct cost for returning the goods. Please send us a written statement about your intention to return the goods via e-mail to zc@zlatanacelje.si. The consumer must return the goods within 30 days of reporting his or her intention of withdrawal. The company must reimburse all payments received from the consumer without undue delay and in any event not later than 14 days from the day on which the company is informed of the consumer's decision to withdraw from the contract.
